





Annual Reauthorization Process is Starting Soon!

It's time to prepare for the annual reauthorization of your child care subsidy!

All families in our subsidy program **MUST** reauthorize to continue participation. The reauthorization application and all required

materials are due no later than September 16, 2024.

The Best Starts for Kids Subsidy will cover child care up to the end of your authorization month. For most families, this period ends on October 31, 2024, while for other families, it extends until November 30, 2024.





<u>Individual family portals will be open</u> in early August for families to submit their reauthorization application and upload required documentation.

What You Need to Know About the Working **Connections (WCCC) Denial Letter Requirement**

Income Limits for Working Connections:

- Families at or below 60% of the state median income (SMI) will be required to submit a WCCC denial letter.
- We suggest that all families estimating their income at 65% or less of the SMI, as shown in the chart below, should submit a WCCC denial letter.
- If your family's income is above 65% of the SMI, you will not be required to submit a WCCC denial letter.

WCCC Denial Letter Requirements:

- Apply to WCCC now to obtain a denial letter.
- The denial letter must be less than 6 months old at the time of submission.
- The denial letter must be based on income or lack of approved activity. A denial letter for an incomplete submission to WCCC will not suffice.
- Families have the ability to request a WCCC denial letter waiver if they

Working Connections (WCCC) Application Process

- The parent must complete the WCCC application and verification
- Apply by contacting the Child Care Subsidy Contact Center at 1-844-626-8687 or online at <u>www.WashingtonConnection.org</u>.
- DCYF will review information to determine a family's eligibility.
- Provide DCYF with the name and phone number of the child care

How to Submit Your WCCC Denial Letter

Option 1: Fax Directly to Best Starts for Kids Subsidy
